- Cllr Finlay reported that the Steering Group had seen a draft summary of the Housing Needs survey which is written by CC's Housing Needs team. 1,486 households were sent

a survey to complete; Cornwall HomeChoice register showed there were 73 households with a local connection looking for affordable rented housing. Of the 73 on the register 27 want a 1 bed, 30 wanted 2 bed and 16 wanted 3 bed roomed accommodation The survey picked up a further 25 'hidden' households who would like an affordable home but are not currently registered with the Council.

Fowey Hospital

Our next meeting is later this month. I recommend we issue a statement to local residents with the update from CPFT's unwillingness to invest money in Fowey Hospital following discussions with NHS Prop Co. Our local MP, Steve Double, is joining us for this meeting.

Parking

I am grateful for the willingness of FTC to consider my request for FTC to work with me to draw up a wider review of parking across Fowey.

Harbour Fowey User Group

I attended the port user group. I expressed my thanks on behalf of the town for the very successful return of the Red Arrows. A suggestion was made that more could be made of the event by the creation of a Festival in the Field type event for the afternoon. The Harbour Commission were supportive but recognised the need for volunteers to come forward. There is a wider issue of often a lack of volunteers for such activities. Please can I encourage the Town Council to do all it can to promote volunteering.

Railing on Town Quay

It has been brought to my attention that there is a broken chain on the higher town quay. I am requesting urgent clarification from FTC as to the ownership of that section of Town Quay. *In response the Town Clerk clarified that the surface area had historically been maintained by*

Restormel Borough Council and this obligation would have passed to Cornwall Council following the introduction of the Unitary Authority. However, FTC was actively trying to acquire a licence for the area; the matter was currently in the hands of solicitors and Cornwall Council had indicated that the authority had no objection to this course of action.

Remembrance Concert

I organised a concert for Remembrance on Saturday 11th November. It was a mixture of Music and Poetry readings. The concert was well attended and those who were there were stirred and moved. I hope we will be able to repeat the event next year.

17/157 Accounts for Approval

It was proposed by Cllr Hughes, seconded Cllr Simms and RESOLVED that accounts to the value of £8157.25 be approved.

17/158 Correspondence

Emails had been circulated and correspondence was left 'on the table' for Cllrs attention.

17/159 Resolutions from Councillors

The Mayor proposed, Cllr Berryman seconded and it was RESOLVED that given the escalating parking problem in Fowey and responses to the initial Neighbourhood Plan questionnaire and the Business Survey, FTC supports the suggestion made by Cllr Virr at the October meeting that FTC works with him to investigate a strategy going forward to address parking issues throughout Fowey, rather than simply reacting to issues in isolation

17/160 Budget 2018/2019

Cllr Berryman explained various aspects of the budget proposals and confirmed the increase in the Squires Field allocation was designed to cover additional work in the car park and to the childrens' play equipment. He then proposed, Cllr Hughes seconded and it was RESOLVED that the budget recommendation from the Finance Committee should be accepted, which would result in a precept of £114,112.00 for 2018/2019.

17/161 Town Quay

It was proposed by Cllr Finlay, seconded Cllr Simms and RESOLVED that membership of the Working Group should be Cllrs Fassam, Hughes, Simms, Stansfield, Woodside and the Group would operate under the following Terms of Reference

- To elect a Chairman at the first meeting
- To investigate options for improvements to the visual aspect of the Town Quay for recommendation to full council
- To ascertain costs of all recommended improvements
- To keep notes of meetings, including actions, for ratification at the following meeting
- To keep the Mayor and Town Clerk fully informed
- To report back to full Council as appropriate

17/162 Electoral Review of Cornwall: Division Arrangements

The Mayor clarified that last year the Local Government Boundary Commission for England (LGBCE) announced it was carrying out a review of electoral divisions in Cornwall. The second part of the LGBCE is to look at the boundaries of our local divisions, which will have to be redrawn. The mould for the new boundaries will be focused on current parishes and CNP's and it is hoped that new boundaries can be formed within these already existing boundaries.

At the moment our elected Councillor Andy Virr represents Fowey, Tywardreath and Golant but it is projected that the average electors per Councillor by 2023 will be 5,163. It was proposed by Cllr Fassam, seconded Cllr Woodside and RESOLVED that FTC should support the creation of a Fowey, Golant, Tywardreath and Par seat by reason of geography, ethos, historic ties. .It was further proposed by Cllr Fassam, seconded Cllr Woodside and RESOLVED that FTC should actively oppose the creation of split Wards.
