21/67 Minutes of the Meeting of the Council held on 21st July 2021

21/70 To receive the Report of the Cornwall Councillor

Main Car Park Coaches Concerns had been raised about the ability of Coaches to enter and exit the Main Car Park. I have contacted four coach companies, but have not received any specific concerns back. I have also spoken with coach drivers on site and no issues were encountered. I am happy to look at this further if any new problems are raised.

<u>Scaffolding on North Street</u> There was an issue with the safety of scaffolding on North Street. I can confirm the scaffolding is correctly erected under license. The minimum width is 2.5 metres, which is compliant. The Fire Brigade worked with Cornwall Council Streetworks to ensure safety for emergency vehicles. Unfortunately, it is not possible to limit scaffolding to out of season only. I have spoken with the owner of the property and insisted that the painting work is carried out with haste.

21/74 Fowey Christmas Market

The Mayor confirmed that, together with the Town Clerk, Cllr Hughes and Cllr Berryman she had met with the potential new co-Chairs of the Chamber and Andrew Weaver (LESW) and she outlined the current position as she understood it. The Town Clerk had also circulated relevant information prior to the meeting. The current co-Chairs of the Chamber had signed a 5 year contract with LESW for the Market without securing a Licence from FTC for the use of the quay. There are 2 years left to run on it. Both Chairs now want to step down from the Chamber but the people taking it forward (Nick from Fowey Hall and Lucy Daniel) have decided not to continue with the 'old' Chamber structure but to start a 'new' Chamber as a limited company and they are not prepared to take on the contract with LESW. Going forwards Nick and Lucy have said that they will not be co-ordinating the 2021 Market and their future intentions in relation to the Market are unclear. LESW now want to deal directly with FTC and cut out the Chamber completely. FTC has previously resolved not to take over the existing contract so, if it was decided to accommodate it, there would need to be a new agreement of some kind. Andrew (LESW) does not support the existing arrangement with Webb Street being used by local traders at a discounted price, although he would come to some sort of agreement with FTC guaranteeing local traders a certain number of stalls. An 'old' Chamber Chair had advised that, even if they were to continue to facilitate the Market, the cost of a stall in Webb Street would have had to increase significantly as currently it was unsustainable to run it. Webb Street is vacated for the duration of the Market by the permit holders on a voluntary basis. LESW want a 3 year licence to use the quay to host the event in a similar way as was in place between FTC and the Chamber and consider the complex contract that was in place between LESW and the Chamber is unnecessary. LESW would undertake to facilitate the following,

- Highways permissions would be applied for by LESW 12 weeks prior to the event date
- LESW would book Albert Quay direct with Cornwall Council.
- Event Risk Assessments were normal for the company and they would supply.
- Event plans were normal for the company and they would supply.
- LESW own all branding and IP associated to the event, including website and social media
- Tidying of the site can be enhanced, LESW would continue to remove anything to do with traders and contractors. Colin has previously been booked for bins
- Chamber has traditionally organised the benches bit with instruction LESW would undertake. The Mayor noted that some regional events have already been cancelled during November and December. St Austell's Torchlight Carnival was cancelled on July 1st because of lack of planning time and uncertainty surrounding the pandemic. Padstow's Christmas Festival has been cancelled because of they were advised that autumn and winter could see new pressures on the NHS caused by ongoing Covid and the resurgence of flu and other winter respiratory illness. They also want to protect their community and volunteers from the stress and health risks involved in bringing thousands of visitors to the town under these circumstances. Members then discussed the future of the Market at some length and noted, *inter alia*, that
- Businesses in Fowey were not supporting the Chamber but were still complaining on social media about the potential loss of the Market. This was unfortunate and hopefully the 'new' Chamber would be able to secure more support.
- Could the 'old' Chamber be offered a licence for the quay for 2021 to enable them to meet the initial terms of their contract with LESW?
- Regardless of how the Market was facilitated, was it sensible to encourage 17,000 people into the town over the Market weekend, given the current pandemic? Cllr Virr noted that most people would have been double-jabbed by December and currently there were no legal restrictions in running the event. If considered appropriate, a licence condition could be included requiring LESW to run the Market in a Covid secure environment, backed up with a Security Plan approved by the Cornwall Council Health Team. This had recently been done for the Boardmasters event in Newquay and meant that Cornwall Council had statutory powers to cancel an event if considered necessary.
- The loss of Webb Street for local traders would be a great loss.
- The Torchlight Parade, Christmas lights, Father Christmas, Carol singing etc. etc. were a big part of the Market weekend. If the Chamber was not involved who would organize these things?
- Could LESW be offered a licence for 2021 and 2022, which would mean the 'old' Chamber contract would be met?

After further debate Cllr Berryman proposed, Cllr Finlay seconded and it was RESOLVED that LESW should be offered the following

1. A 2-year licence to use the quay and Webb Street, but on the basis that the permit holders agree to vacate their spaces in Webb Street and it can be secured 2. The terms of the licence would be on the basis of that previously granted to the Chamber, but with additional conditions requiring LESW to deliver the agreed actions (above) and, also, to provide a Security Plan approved by the Cornwall Council Health Team. 3. The cost would be £1,500 pa to include Webb Street but this would be reduced if Webb Street was not available. 4. LESW to undertake to accommodate a minimum number of genuine local traders at the reduced rate of £170, either in the main tent or in Webb Street, but on the basis that if these pitches were not sold by a cut-off date agreed between LESW and FTC, LESW could fill them with traders paying the full price. This minimum number to be agreed between LESW and FTC.
