22/79 Planning Applications

1. PA22/04484. Advert Consent: Installation of a camera pole, signs mounted on signage poles and walls/fence of the car park. Rashleigh Arms, Polkerris, Par, PL24 2TL. Whilst members appreciated the real problems during the summer months from the amount of cars trying to access Polkerris, they queried the necessity of so many signs and the height of the proposed camera and also noted the objections from ANOB and Historic Planning. Cllr Dellow proposed, Cllr Day seconded and it was RESOLVED that a recommendation of objection should be made to Cornwall Council. *Reason: The proposals are harmful to the setting of the surrounding listed buildings; the prominence of the camera pole and overly conspicuous signage is unacceptable at this sensitive location, within the Polkerris Conservation Area and visible from the beach and coastal footpath.*

2. PA22/04483. Car park management system (ANPR, associated signage and Pay and Display machine). Rashleigh Arms, Polkerris, Par, PL24 2TL. Cllr Dellow proposed, Cllr Day seconded and it was RESOLVED that a recommendation of objection should be made to Cornwall Council. Reason: The proposals are harmful to the setting of the surrounding listed buildings; the prominence of the camera pole and overly conspicuous signage is unacceptable at this sensitive location, within the Polkerris Conservation Area and visible from the beach and coastal footpath

Cllr Finlay and Cllr Day declared a non registerable interest in the next application and left the meeting, Cllr Dellow proposed, Cllr Simms seconded and it was RESOLVED that Cllr Berryman should take the chair for this item.
