### 25/16 Planning Applications

- 1. PA25/02520. Proposed dormer extension. 39, Green Lane, PL23 1DX. Cllr Gibbon noted that this was actually a loft conversion, rather than a simple dormer extension. It was proposed by Cllr Gibbon, seconded Cllr Simms and RESOLVED that a recommendation of no objection should be made to Cornwall Council
- 2. PA25/03735. Proposed Ground Floor extension to side of existing detached house, enlargement of existing conservatory, erection of carport over new off road parking space with new access to road. 53, Hill Hay Close, PL23 1EL It was proposed by Cllr Dellow, seconded Cllr Simms and RESOLVED that a recommendation of no objection should be made to Cornwall Council, but noting some concern about the use of polycarbonate on the carport which would be out of place in the streetscene.
- 3. PA25/03886. Replace an existing modern single-glazed timber bi-folding doorset to the rear elevation, with a new white framed aluminium doorset (double-glazed). Old Quay House Hotel, 28, Fore Street, PL23 1AQ. It was proposed by Cllr Dellow, seconded Cllr Day and RESOLVED that a recommendation of no objection should be made to Cornwall Council

- 4. PA25/03887. Listed Building Consent to replace an existing modern single-glazed timber bi-folding doorset to the rear elevation, with a new white framed aluminium doorset (double-glazed). Old Quay House Hotel, 28, Fore Street, PL23 1AQ. It was proposed by Cllr Dellow, seconded Cllr Day and RESOLVED that a recommendation of no objection should be made to Cornwall Council
- 5. PA25/04151. Proposed extended dormer to form en-suite. 16, Vicarage Meadow, PL23 1DZ. It was proposed by Cllr Gibbon, seconded Cllr Day and RESOLVED that a recommendation of no objection should be made to Cornwall Council

Cllr Gibbon drew members attention to an email from CC planning in relation to a planning application at 15, Polmear Hill, which FTC had previously objected to. There was still some concern about the size of the proposed property but overall they confirmed that they would be inclined to look more favourably on this design.
