1. Election of Chairman 2011/2012

It was proposed by Cllr Alexander and seconded by Cllr Tony Vincent and RESOLVED that Cllr Jane Vincent be elected as Chairman of the Environment Committee.

6. To approve the Minutes of the meeting held on 16th February 2011

It was proposed by Cllr Alexander , seconded by Cllr Tony Vincent and RESOLVED that the Minutes of the Meeting held on 16th February 2011 be accepted.

7. OGS Garden

Cllr Jane Vincent said that there was a need to get a third quote for the repair of the steps leading to the Gardens. Cllr Alexander was asked to approach Mike Davis. Cllr Alexander suggested that there could be improved signage in relation to donations. Cllr Jane Vincent reported that Nigel Retalick has plans for the Gardens, which were done by a landscape gardener but would be costly. Cllr Alexander suggested that the donations could be used toward this. Cllr Jane Vincent said that she was worried about the apparent piecemeal additions to the Gardens and would check his contract to find out what he had to provide. Cllr Jane Vincent said that she would be making enquiries in regard to obtaining a water supply

Cllr Jane Vincent reported that there were problems with "Hydrangea Row". Hydrangeas were not suitable plants to grow under trees when there were dry conditions as encountered earlier in the year.

8. Grass Cutting/Weed Control/Footpaths

Cllr Alexander reported that she had had difficulty contacting Tim Rhodes. She was worried that he seemed to be working on his own initiative and not as requested. Despite requests to the contrary, he was still sending blanket bills. It

was agreed that his position was to be reviewed at the September/October meeting to the Committee.

9. Environment Budget

To date Tim Rhodes had received £1035.00 and Nigel Retallack had received one amount for £332.70 and one for £241.50.

10. Agency Agreement

11. New Road Hill Embankment
