#### 11/74 Public Questions

The agent representing the applicant in respect of PA11/09694 explained incorrect plans had been submitted with the application. These plans were in fact the ones for a former application which had been refused by both FTC and CC. The correct documentation had now been lodged with CC and the application amended to show no alterations to the front of the building apart from some work to the patio.

The Clerk confirmed that CC had advised that the time limit for responses had been extended until 21<sup>st</sup> December because of the amendments so it was agreed that a decision on this item should be deferred until the planning meeting on 14<sup>th</sup> December to enable members to study the revisions.

## **11/77 Planning Applications**

1. PA11/09298. Formation of dormer window to rear elevation. 6a, Tower Park. Proposed Cllr Gudmunsen, seconded Cllr Alexander and RESOLVED that a recommendation of support should be submitted to Cornwall Council. *Reason: The proposals would have no adverse effect on the streetscene or neighbouring properties.* 

- 2. PA11/07635. Extensions to front and rear; raise roofline with rear dormer window. 20, Esplanade. Proposed Cllr Boosey, seconded Cllr Vincent and RESOLVED that a recommendation of objection should be submitted to Cornwall Council. *Reason: The proposals were out of keeping with the streetscene and overbearing in relation to neighbouring properties.*
- 3. PA11/09514. Creation of links at first and second floor via doorways. Clocking up of one staircase. Relocation and creation of additional bathrooms. Upgrading of plumbing and electrical services. Remediation works requiring damp proofing. Creation of internal utility room. Replacement of roof slates and erection of hipped roof over flat roof extension. (All other detail contained in the Design & Access Statement). 4 & 5, Cobbs Well. Proposed Cllr Alexander, seconded Cllr Vincent and RESOLVED that a recommendation of support should be submitted to Cornwall Council. *Reason: This was a sympathetic scheme to improve a distressed property*.
- 4. PA11/093262. New pitched roof to existing dormer and a first floor extension to rear. 4, Harbour View. Proposed Cllr Gudmunsen, seconded Cllr Alexander and RESOLVED that a recommendation of support should be sent to Cornwall Council provided the front dormer was the same size as the existing one..
- 5. PA11/09694. Proposed replacement for 2 storey extension and front balcony. Formation of Juliette balconies at 2<sup>nd</sup> floor level and landscaping. 19, St Fimbarrus Road. Deferred until 14<sup>th</sup> December.
