# 14/201 Apologies

#### 14/202 Declaration of Interests

# 14/204 Minutes of the Meeting of 18th February 2015

It was proposed by Cllr Delves, seconded Cllr Boosey and RESOLVED that the minutes be confirmed and signed by the Chairman.

#### 14/205 Matters Arising not on the Agenda (for report only)

- Allotments No report.
- St Catherines Lights The Mayor reported that he had met with English Heritage on site. It was hoped that the revised scheme would receive approval from the EH Inspectorate and Chris Biggs could undertake the installation. However, EH had indicated that if the new scheme did not work then a line should be drawn in the sand and the Castle should

remain unlit. EH had hoped that FTC would tidy up the original lighting but the Mayor had declined as it was not FTC's responsibility, although he had agreed that the flagpole would be returned to its original position at FTC's expense if the new scheme was unworkable..

- Wainhomes The Town Clerk reported that she had contacted Wainhomes about the
  replanting of the Field of Hope and the general tidying-up of the bank and she had been
  assured that this would be done, albeit there had been a suggestion that daffodils could be
  planted on the new amenity ground rather than on the original site. The Clerk had
  arranged for Wainhomes to liaise with the Environment Committee and Cllr Finlay
  confirmed that she was monitoring the situation.
- Good Citizens Award An invitation for public nominations had been included in the Mayors Column in the March Fowey News but the Clerk confirmed that to date she had not received any.

**Town Hall** – minutes noted. The Clerk reported that she had been contacted by Molly King, who was very keen to see disabled access to the Hall. The Clerk had assured Mrs King that FTC would be supportive of any realistic scheme but that, to date, no feasible way of introducing it had been found. Clearly, any realistic suggestions from the public would be welcomed but it had to be borne in mind that the Town Hall was a listed building and previous attempts to establish external disabled access had been turned down by CC Planning..

**Forum** – Cllr Willmore reported that the Forum was looking into the possibility of tidying up the bus shelters and was working with the Chamber in respect of improvements to signage.

#### 14/213 Neighbourhood Plan

Cllr Finlay reported that the NP Exhibition in Polkerris had been well attended and some positive feedback had been received. It had been interesting to note that some residents had been unaware that Polkerris was in Fowey parish and also that the Fowey News was not made available there. This had now been rectified, with 30 copies being delivered to the Rashleigh Arms. Several items of expenditure – display boards, flyers, questionnaires etc. - had been met from funds from the bridging grant, which Cllr Finlay noted must be spent before the 31<sup>st</sup> March. An application for a further grant had been submitted. The Primary School was also getting involved in the NP with Year 6 children participating in a project on 'What Makes Fowey Special?'

# 14/214 Squires Field

The Fowey Bowling Club had indicated to FTC that the Club had been dissolved and the Trustees wished to surrender their lease and also that they hoped to sell tables, chairs, kitchen equipment etc. to FTC. The Clerk had advised them to contact Cornwall Council in connection with the surrender as the transfer of Squires Field had still to be completed..

#### 14/215 Fowey Public Conveniences

The Clerk confirmed that she had received quotes for the refurbishment of the Town Quay facilities, which members could consider later in the meeting during Closed Session. Transfer of the towns' facilities was still with Cornwall Council legal.

#### **14/216 Town Quay**

<u>Christmas Market 2015.</u> Lynn Gould was overseeing the tender process and would hopefully report back to FTC at the April meeting.

General Update The light by the slipway steps was now working and Chris Biggs would be quoting for the repairs to the fendering. The Town Clerk queried what members wished to do about the provision of a signpost but after some discussion it was agreed that a decision should be deferred until the April meeting.
