#### Police Report

PCSO Paynter had supplied the following report and crime figure relating to the period  $1^{st}$  April  $-10^{th}$  May.

- 4 x Theft. A mobile telephone was stolen in a local pub. Undetected. A pick-pocket was active in a local pub. Another theft at a local shop. (Please see below)\*\*\* A car window was smashed and an item stolen (Undetected)
- 4 x Criminal Damage. An air gun pellet smashed windows in two properties in Vicarage Meadow (Undetected). A sheep was killed in a dog attack (Undetected). A door was damaged in Troy Court.
- 1 x Threat to Damage/Destroy. This was filed as undetected
- 4 x Assault/ABH. Two Historic Assaults at the same address (Both On-going). One whereby a person was charged to court (On-going). Another historic case awaiting court (On-going)
- 1 x Harassment/Breach of Order. One charged to Court (On-going)
- 1 x Send False Message/Communication. This has been sent forward for no-criming
- 1 x Non-accounting action fraud. Basically a civil offence (Undetected)
- 1 x Attempted Burglary. A rock was thrown through a window at Fowey Hospital (Undetected)
- 1 x Affray. This was an "after hours" disturbance (Undetected)
- 1 x Assault by Beating. Related to one of the above assaults (On-going)

\*\*\* After several years of repeat thefts I am delighted to say that, thanks to some great work by PC Barnicoat, the latest attempt was foiled and the perpetrators were apprehended. I am sure that several people in the Town have heard about this and we would like to thank a member of the public who assisted PC Barnicoat in a successful arrest. The perpetrator has been charged to court. \*\*\*

As you will see, two of the above Criminal Damages relate to airgun pellets being fired at properties in Vicarage Meadow. As first floor windows on neighbouring properties were damaged, it would seem likely that someone is taking shots at seagulls. We all know that seagulls can be a nuisance however, it is an offence and, if caught, it could prove very costly for the perpetrator. I am sure that the offender lives close by so, please, whoever you are, be sensible!

Scammers are still on the warpath and constantly cause alarm and distress to their victims. I have had a recent report that someone was very close to being caught out by the, what is now, very old BT scam. This involves criminals contacting you acting as BT representatives and asking for your bank details in return for services. Please protect vulnerable people and make them aware that these people will fleece you of large sums of money given the opportunity. A similar scam is run by people who claim to be Microsoft representatives who will try and gain remote access to computers. Prior warnings are key to stopping these people in their tracks.
