The Mayor reported

- I was very pleased to see the new disabled swing in the playground at Squires Field. The mum, who had approached Fowey Town Council, said her son loved to play on swings but needs to have a specialist seat. She got back to me last week to say thank you. Thanks also to Cllr Virr who also provided a grant through his ‘community chest’ towards the costs of the new swing.
- On 4th December I attended a briefing event for St Austell Bay Economic Forum. Members of St Austell Bay Economic Forum, who include major businesses, the local college as well as local councils and community groups, are working together to bring about positive economic change in the St Austell bay area. There was a professional presentation from the marketing company Thinking Places – which has worked with 20 Northern towns to help their rejuvenation, hence their involvement in St Austell. There will be a launch in the press soon to publicise the priorities of this group.

Fowey Hospital

I have chaired a further meeting of the Fowey Hospital working group. I am grateful for the contributions of Fowey Town Council members. Phil Confue, the CEO of CPFT, has agreed to

attend our meetings to work in partnership with us to find a positive way forward for the hospital. I have also requested a joint statement to ensure local residents are kept in the loop.

Christmas Market

The Christmas Market was a great success and it was terrific to see Fowey full of locals and visitors. Large crowds attended the arrival of Santa Claus on the Friday evening and the marquees were bustling with shoppers.

Town Carol Service

In my personal capacity, I was the music director for the Fowey Town Carol Service. I was able to bring together local schools to sing with my choir the Fowey River Singers and a quintet from St Austell Brass Band. The service was well attended and appreciated by those who went.

Retail closures

I am concerned about the number of vacant shops on the high street. I am very keen to work with Fowey Town Council, The Chamber of Commerce and the Fowey Forum to look for solutions.

Parking

I am meeting with the Mayor, Deputy Mayor and Town Clerk to discuss recent parking concerns and encouraging them to work up a Parking Strategy for Fowey.

Planning

I have received a number of concerns regarding the proposed development on Island Field, south of Lankelly Lane. I am meeting with residents next week to listen to their concerns.

Thanks to Fowey Town Councillors for all their hard work this year. As local councillors you are a vital part of the local fabric in Fowey. 17/163 Questions/Reports from Members (taken at the discretion of the Mayor)

The Mayor reported

FTC had received a letter from Cllr Alan Percy from Cubert parish council who are also part of the North Coast Cluster Group of parishes. The letter is about the 'lack of increase in annual Public Footpath (LMP) and street cleaning agreements and the statutory duty of CC highways to maintain streets, public footpaths and bridleways'.

1 CC expect councils to set their precept without knowing what the rate of payment will be for the forthcoming year

2. This cluster group have been asking for an increase in the LMP agreement rates to at least national minimum wage, for many years; what is happening is parishes are subsidising the costs to carry out what is the statutory duty of CC.

3. Reviews were supposed to have taken place in 2015, 2016, 2017 and didn't. The last rate agreement occurred in 2007/8

The Mayor requested members approval for her to write back to Cllr Percy to support his efforts. This was given

The Mayor then drew members attention to the Spirit of Fowey - Citizen of the Year and Group of the Year for 2018 and stated that she would like to start a young employee/apprentice of the year. Small businesses were not having a particularly easy time in Fowey with the number of empty shops and the number of businesses being sold; she would like to highlight that they employ local people and particularly Fowey's young people and she would like to recognise this with a new Spirit of Fowey Young Employee of the year. Members supported this initiative and it was agreed that the age range should be up to 25 years.
